Earlier this year, job vacancies have just been opened for tax professionals in the UAE for the establishment of the Federal Tax Authority, which is now up and running.

Additionally, it is expected that companies will need to deal with the restructuring of their finance and IT departments as well as orienting the staff with regard to what the VAT will bring to the industry and how it can affect a company as a whole.

Businesses are expected to be preparing or already setting up VAT control accounts and software to keep their accounting records in compliance with the federal tax authority. In this case, companies would be in need of additional human resources or

Nowadays, especially that January 1 is simply less than three months away, companies are getting prepared with the VAT, and VAT consultants, auditors, accountants, analysts, and call centre agents, among others. These professionals are now being searched for by organisations, with the demand for these people or staff expected to increase even more as the VAT roll-out draws closer.

Qualified IT professionals are being sought especially because firms are in need to transform ERP systems into having designs that will accommodate or enable the VAT implementation, which means that most companies will have their eyes on ERP and technology specialists.

Moreover, it is also expected for the consultancy firms to increase their resources for the upcoming anticipated rise of the demand for their services. Since there are small- and medium-sized companies in the UAE, they would likely reach out to consultants for the registration for VAT and the training of employees as well for maintenance and management.

There are a lot of changes that are presumed to happen with the coming implementation of the VAT, which will be a new concept for most people in the UAE. It is seen as a positive thing by a lot of the residents of the UAE as VAT will clearly help with the growing economy although there are challenges that need to be tackled by the organisations.
